No.FEB.331/2015/86: In pursuance of Clause 3 of Article 166 of the Constitution of India and all powers enabling in this behalf, the Governor of Assam is pleased to direct that the following partial amendment has been made in Notification No.FEB.331/2015/10 dtd 29th May, 2018 in Schedule-I of the Delegation of Financial Power Rules, 1999 (as amended).
