- 2. W.e.f. 01/12/2018 all proposals on Re-appropriation and CF Advance must be submitted online only.
- 3. Online proposals will be received and processed by Budget Branch & in case of specific classification, the same will be sent online to concerned EC branch for necessary views.
- 4. These proposals can be initiated at the level of either the HoD or the Administrative Department.
- 5. Proposals initiated by HoD will be scrutinized by the concerned Administrative Department.
- 6. The Administrative Department, subject to scrutiny and correctness of the proposal, will forward the proposal to Finance Department.
- 7. On approval by Finance Department, the same would directly be communicated to the concerned office(s) online.
- 8. All users will be able to access the modules from their existing login credentials already assigned for use of the *finassam.in* portal.
