NOTIFICATION

In continuation of the notification issued vide No FIF. 89/2020/48 dated 14/08/2020 and in exercise of the Clause 8 of the aforesaid notification, Governor of Assam is pleased to make following amendments:

1. Under Clause 2(v) Distribution of Target to be read as follows:

The distribution of target shall be 15,000 beneficiaries per Legislative Assembly Constituency (LAC) if the number of electorates is within 1,50,000 (one lakh fifty thousand). In case, where the number of electorates exceed 1,50,000, the distribution targets for beneficiaries would be as under:

Number of Electorates	Target Beneficiary
Below 1.5 Lakh	15,000
Above 1.5 Lakh and Less than 2 Lakh	16,000
Above 2 Lakh and Less than 2.5 Lakh	17,000
Above 2.5 Lakh and Less than 3 Lakh	18,000
Above 3 Lakh and Less than 3.5 Lakh	19,000
Above 3.5 Lakh and Less than 4 Lakh	20,000

The number of electorates in a LAC may be determined from the electorate list of 2019, General Elections at the district level.

2. <u>Under Clause 5.2 Implementation Process</u>, an additional sub-point 5.2(x) is added as follows:

Government of Assam through *Orunodoi* scheme guarantees to cater to the health and nutritional needs of poor families and relieve them of the distress of poverty. It has been observed that many homeless, destitute, beggars, transgenders, families of inmates, etc may be living under immense socio-economic distress and may not be able to get themselves enrolled in the Scheme. To facilitate this, Deputy Commissioners are hereby accorded discretion to select 500 such households living under socio-economic distress. DCs may ensure that such beneficiaries are enrolled in the Scheme and receive benefits under the Scheme. This discretionary quota will be over and above the LAC wise targets already fixed vide 1 above, and will be solely at the discretion of the concerned Deputy Commissioners.

The other conditions laid down under the aforesaid para would remain same.
