No.FEB.131/2011/12 In pursuance of Clause 3 of Article 166 of the Constitution of India and all powers enabling in this behalf, the Governor of Assam is pleased to direct that the following temporary power (till 31st March 2020) shall be delegated to the Chairperson of Executive Committee, KIYG 2020 and the Chief Executive Officer, KIYG 2020 in relation to various items of expenditure in connection with Khelo India Youth Games, 2020 under Schedule-III of the Delegation of Financial Power Rules, 1999 (as amended).
