OFFICE MEMORANDUM

Subject: Interest Subsidy Scheme for differently abled employees of State Government for purchasing of disabled friendly conveyance (car/two wheeler).

In continuation of this Department's earlier Office Memorandum No. FM 7/2010/31 dated 20th June 2017, the Governor of Assam is pleased to formulate the following procedures and guidelines in connection with purchasing of differently able friendly conveyance (car/two wheeler):

- The Government will provide interest subsidy of 4% to the differently abled State Government employees to purchase disabled friendly conveyance (car/two wheeler) which costs higher due to modifications through all scheduled commercial banks providing auto loans, depending upon the choice of the beneficiary/loanee.
- 2. The subsidy amount would be released by way of credit to the salary accounts of the employees from where installments towards the car loan are to be recovered by charging to the pre-funded subsidy account maintained by the Government of Assam.
- 3. The auto loans would be granted for purchase of New Two Wheelers, Passenger Cars and Multi Utility Vehicles (MUVs).
- 4. Loans will be sanctioned by the bank as Term Loan.
- 5. Regular State Government Employees between the ages from 21 to 53 years shall be eligible for this scheme, so that the maximum tenure of 7 years of loan comes within the service period of the employee.
- 6. The maximum Loan amount shall be 48 times of the Net Monthly Income or $\stackrel{?}{\underset{?}{\sim}}$ 10 Lakhs, whichever is lower.
- 7. The scheme shall be applicable to all existing differently abled car/two wheeler loanees who have already taken auto loans from scheduled commercial banks and are State Government employees.
- 8. The Net Annual Income (Gross monthly income net of all statutory deductions) and/or co-applicant*, if any, together should be ₹ 3,00,000/- and above.
 (* co-applicant means spouse, father, mother, brother, sister, son and daughter with valid income proof)
- The Bank shall finance 85/90% of the on-road price of the vehicle or 48 times of Net Monthly Income, whichever is lower.

- 10. The repayment of the Auto Loan shall be for a period of minimum 3 years and maximum 7 years. The repayment shall be fixed on the basis of Equated Monthly installment with checkoff facility/PDC/ECS.
- 11. Registration of the vehicle to be done with Bank's hypothecation charge duly noted and a copy of Registration Certificate to be submitted to the Branch for record.
- 12. Comprehensive insurance covering all risks to be done before taking delivery of the vehicle with Bank's charge duly noted and Bank's copy of the policy to be submitted to the Branch for record.
