The service of Sri Rajib Sarkar shall be governed by the "New Defined Contributory Pension Scheme 2009" and the incumbent is liable to furnish an undertaking to the undersigned alongwith his joining report as prescribed by Govt. letter NO.BW/3/2003/Pt.-II/1 dated 25.01-2005 regarding acceptance of "New Defined Contributory Pension Scheme "as follows:-

"Certify that I understand and accept the Govt. servant joining the service of the State Govt. on or after 01.2.2005 shall not be governed by the existing Assam Service (pension) Rules 1969 and order issued there under from time to time and their pension and other retirement benefit will be governed by "New Defined Contributory Pension Scheme 2009 "issued vide Finance Department OM NO.BW.7/2008/pt./40 dated 6.10.2009.

Moreover, at the time of joining he shall have to furnish medical fitness certificate from the Competent Authority.

Further he shall have to submit all the original copy of the certificates as mentioned in the calling letter vide No.DA. 56/2016/100,dated 7.3.2018 for verification.

No TA/DA shall be admissible for the purpose of his joining in the post.
