ORDERS BY THE GOVERNOR OF ASSAM
NOTIFICATION

Dated Dispur, the 3rd October, 2019

In suppression of Finance (EC-II) Department's earlier Notification No. FEC(II) 4/2014/413, dated 08/03/2019, the following are hereby notified for compliance by all State Government Departments as applicable for the Muster Roll/Work charged/Casual and similarly placed employees who were engaged prior to FRBM period i.e. 1st September, 2005 (Govt. notification No.FEA.104/2005/11, dated 26.08.2005).

1. The fixed wages/remuneration of Rs.15900/- with Dearness Allowance (DA) will be admissible which will undergo revision whenever pay scale changes based on enhancement of DA and recommendation of Pay Commission, alongwith Medical Allowance of Rs.600/- per month.
2. Work Charged categories of workers who are already drawing a higher pay band (PB-2)/or existing in PB-1 will continue in the existing pay scale.
3. These employees will draw their wages under the Head of Account, "01- Salary' as other regular employees of the Government for Administrative convenience. However, they will not be considered as regular employees and no such claim can be made on this basis.
4. Further, the eligible MR/WC/ Casual Employees will be covered under the Pradhan Mantri Suraksha Bima Yojana, Pradhan Mantri Jeevan Jyoti Bima Yojana and Atal Amrit Abhiyan and the premia for the same will be paid by the State Government.

Arrear claim from 01.08.2017 to 30.11.2018 shall be considered after Cabinet approval, in the financial year 2019-20.

The benefits as entailed above shall be admissible on specific recommendation of the Committee constituted in compliance of the Hon'ble High Court's order dated 8th June, 2017 in WA . 45/2014 (State of Assam -Vs- Upen Das & Others), notified vide FEC(II) 04/2014/346, dated 31.08.2017 and formal approval thereof by Hon'ble Minister, Finance, Assam.

This will come into force from 01-12-2018 for release of benefits till date.
