4. Qualification criteria:

- a. The bidder should have been registered with state Goods and Services Tax (GST).Copy of such certificate including Self-attested copy of PAN card shall be enclosed as a proof.
- b. Registration certificate of bidder under any suitable act e.g. shop and Establish Act, Company Act, Partnership Act etc. Copy of such certificate shall be enclosed as a proof.
- c. Bidder should have a functional registered Office within 10 KM radius of Consignee Location.
- d. Bidder should have a proper service set up with minimum 3 Technicians. Valid proof of appointment to be attached.
- e. The bidder must submit an affidavit/signed undertaking for not blacklisted by any other Government Organization.

5. Bid Price:

- a. The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re writing will not be accepted.
- b. All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- c. The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d. The Prices should be quoted in Indian Rupees only.

6. Submission of Bids:

- a. A bidder shall submit the quotation in one sealed envelope only.
- b. The bidder must mention full detail of specification of the items quoted. Mere mentioning words like" complying"/"compliable" is not sufficient.
- c. Envelope containing quotation must bear on the cover itself, name of item bidding for, name and full address with phone numbers of the bidder.

7. Delivery Terms and Liquidated Damages / Punitive deduction:

The selected bidder shall deliver and install all the batteries and repair the online UPS at the delivery locations as per specification above within 7 days after award of contract. For delays, the applicable rate is 0.5% per week and the maximum deduction is 5% of the contract price. On further delays, purchase order may be cancelled.

8. Validity of Quotation

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

9. Evaluation of Ouotations

AS-CFMS will evaluate and compare the quotations determined to be substantially responsive i.e. which are properly signed; and conform to terms and conditions, and Specifications.

10. Award of contract

- a. AS-CFMS will award the contract to the bidder whose quotation has been determined to the substantially responsive and who has offered the lowest evaluated quotation price.
- b. Notwithstanding the above, AS-CFMS reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- c. The bidder whose bid is accepted will be notified of the award of contract by AS-CFMS to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order
