**No. FEB.297/2017/Pt I/102:** The Governor of Assam is pleased to appoint Shri V. B. Pyarelal, IAS, presently posted as Chairman, Assam Administrative Tribunal and Assam Board of Revenue, as Chief Commissioner of PRANAM Commission which is constituted vide No.FEB.297/2017/Pt-I/101 dated 18<sup>th</sup> February, 2019 under Section 18 (4) of "the Assam Employees' Parent Responsibility And Norms for Accountability and Monitoring Act, 2017" enacted by the Govt. of Assam, subject to the condition that he ceases to be the member of the Indian Administrative Service.
