 - All concerned line departments are requested to follow the guidelines issued by the Ministry of Housing Urban Affairs, Govt. of India for utilization of ULBs tied grant under 15th FC award which has been forwarded to the line departments i.e. UDD, GDD, WPT&BC & Hill Areas for ensuring strict compliance.
 - vi) All concerned line deptts. are requested to submit the status report of implementation of the schemes under 14th FC award.
 - vii) The Concerned line Departments / Principal Secretaries of the Autonomous Councils are requested to prepare action plan for tied and untied grant for 2020-21 and submit the same to Finance (EA) Department along with concept note relevant supporting details for approval of the HLMC.
