In pursuance to the Notification No. FEA(SFC) 31/2023/138 dtd. 01/07/2024 regarding constitution of the Seventh Assam State Finance Commission under the Chairmanship of Lieutenant General Rana Pratap Kalita, PVSM, UYSM, AVSM, SM, VSM (Retd.) following terms and conditions have been fixed against his appointment:

- 1. Difference between last pay (except Medical Allowance and House Rent Allowance) drawn as it would have been at present after revision minus pension deemed to be honorarium shall be paid.
- 2. Status in the rank of the Chief Secretary is accorded to the Chairman of the Commission.
- 3. Tour within the State without the permission of the Chief Minister may be undertaken by the Chairman as deemed necessary.
- 4. For tour outside the State in connection with SFC related works, the Chairman is to take prior approval of the Chief Minister. TA/DA shall be entitled as admissible in the rank of the Chief Secretary.
- 5. Reimbursement against expenses of entertainment and refreshment up to the limit of Rs.10000/- only per month will be admissible.
- 6. Reimbursement against bills of Mobile Phone up to the limit of Rs.2500/only per month will be admissible as per Office Memorandum No. GPT.7/2004/58 dated 30/08/2014.
- 7. Reimbursement against cost of three Local Newspapers and seven National Newspapers is admissible. In addition to that, Books and Periodicals, Magazines etc. worth Rs.900/- only per month are also be admissible as per Office Memorandum No. PSP.2/2001/112 dated 08/05/2007.
- 8. A suitable car with a driver shall be provided to the Chairman by General Administration Department.
- 9. Reimbursement against cost of 60 liters of petrol or diesel per month shall be admissible as per Office Memorandum No. FM.136/88/51 dated 28/06/1993.
- 10. Personal staff including stenographers and peons shall be provided by the G.A. (S.A.-Estt.) Department for the Chairman.

11. The Chairman shall be entitled to engage a two helpers at his residence as per procedure and as admissible to the Senior Grade Officer of the State Government as per Office Memorandum No. GA(SN) 274066/5 dated 24/08/2023.

If there is any upward revision in any of these allowances, the same shall be provided to the Chairperson instantly.
