NOTIFICATION

In pursuance to the Finance department notification issued vide No.FIF.99/2020/Pt-III/39 dated 29th September, 2020, relating to Guidelines for implementation of the Scheme 'Re-SVAYEM', and in exercise of the para 11 of the aforesaid notification the following clarification is hereby issued:

1. Registration of SHG's:

- a. As of it is noted that there is no system of SHG registration as of now. Therefore, for essential eligibility criteria under clause 4.1(e) of Re-SVAYEM Guidelines, the date of opening up of joint group bank account by the said SHG/JLG in a Scheduled Commercial Bank may be considered as the date of formation of SHG/JLG.

2. Mechanism to check bank loan Default:

- a. As per the clause 4.1(i) Re-SVAYEM Guidelines, for extending the benefit under the Scheme, application of all SHGs/JLGs shall mandatorily be scrutinised for any bank loan defaults, in respect of either individual or group bank accounts, through the CIBIL mechanism.
